WHEREAS, the City of Georgetown, Illinois, a municipal corporation, acting through its corporate authorities has determined it to be in the best interests of the inhabitants of the City, and

WHEREAS, 65 ILCS 5/3.1-50-10 does authorizes the municipality to fix the salaries of all municipal officers, including that of Mayor, Alderman, City Clerk and City Treasurer,

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Georgetown, Illinois, as follows:

Section 1: This Resolution amends the Municipal Code and to the extent that this resolution is inconsistent with the provisions of the Municipal Code, the same are hereby repealed.

Section 2: Municipal Code 2.04.050 is hereby repealed, and the following is substituted in its stead:

A. The Mayor shall receive an annual salary of five thousand dollars, paid in monthly installments. In addition to the annual salary, the mayor shall be paid sixty dollars for each special meeting of the city council attended and twenty dollars for each study session and twenty dollars for each committee meeting attended.

B. Aldermen shall be paid sixty dollars for each regular meeting of the city council attended; sixty dollars for each special meeting of the city council attended; and twenty dollars for each committee meeting attended, in which they are a member.

C. The city clerk, an appointed position, shall receive an annual salary of no less than ten thousand dollars and paid in monthly installments. In addition to the annual salary, the city clerk shall be paid sixty dollars for each special meeting of the city council attended and twenty dollars for each study session and twenty dollars for each committee meeting attended. The salary may be reviewed and adjusted annually.

D. The city treasurer, an appointed position, shall receive an annual salary of not less than twelve thousand dollars and paid in monthly installments. In addition to the annual salary, the city treasurer shall be paid sixty dollars for each special meeting of the city council attended and twenty dollars for each study session and twenty dollars for each committee meeting attended. The salary may be reviewed and adjusted annually.

E. The city collector's salary shall be fixed by the city council in the annual appropriation and budget ordinance, and the salary shall be paid in bi-weekly installments, and shall be paid one-third from the general budget, and one-third each out of monies collected in and through the water and wastewater departments respectively.

F. In lieu of regular compensation for committee meetings, the chair of that meeting shall receive thirty dollars.

G. In the absence of the mayor from a regular meeting of the city council, the mayor pro-tem shall receive the mayor's salary for that meeting, in lieu of aldermanic pay.

H. All changes in compensation established in this section shall be effective with the first pay period following the election in April of 2021, as to those persons elected at that time, and effective with the first pay period following the 2023 election as to all others.

Section 3: The City Clerk is empowered to publish this resolution in pamphlet form.

Section 4: This resolution is hereby passed by the affirmative vote, the “ayes” and “nays” being called, by at least two-thirds of the members of the Council of the City of Georgetown, at a regular meeting of the Council on the 19th day of October 2020.

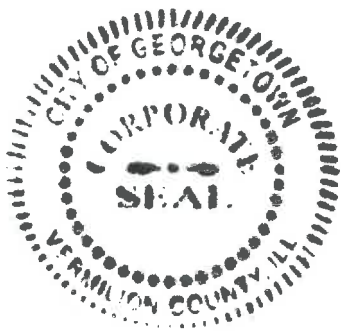
