# Georgetown City Council Meeting Minutes for May 19, 2025

The Georgetown City Council met in regular session at the hour of 7:00 p.m. in the Council Chamber, City Hall, on the above written day.

Invocation delivered by Alderman Gordon Pledge of Allegiance was recited.

Mayor Readnour declared a quorum was present.

The mayor moved New Business item #1 first, to allow Jon Anderson of Hoerr Construction to talk to the council. Hoerr Construction does underground utility work. Jon wanted to talk to the council about trenchless rehabbing of sewers. There is currently 5 million feet in the ground of CIPP. This procedure would be done from manhole to manhole, on a pipe that needs work. The total project takes around 6 hours. This is fully developed, proven technology. It is cost effective with a wide range of applications. They cannot use this if the pipe collapses. The price depends on the circumstances. The company can come in and clean the pipe and tv for \$5,000 a day. This will give them an idea if they are able to fix the pipe this way. This has been used for over 50 years, never had to tear it out. They will inspect it when applied, if there are any blemishes they will fix it right then.

The clerk issued a golf cart permits to Shannon Whittaker, Richard Dailey, Jr, Kenny Dailey, Tim Hart, Carolyn Hughes, Heather Nickle, Troy Winland, Chad Steinbaugh, Tracy Isaacson, and Dale Brooks. The clerk also collected waste pad payments totaling \$1870.00.

West St, dirt work on Seminary St from sewer work, put out asphalt in holes around town. **Did work orders, read meters, shut off list, Bad meter list, and J.U.L.I.E.'s**. Water & Sewer Reports: Ed – daily chores, CSO report, water report, sewer report, monthly testing, and submitted info to Gemina group for CCR's, and water usage report, mowed sewer plant, did labs, and checked oil and switched blowers in lagoons. Will – cleaned glass bowls on all pumps at Georgetown sewer plant every two weeks, mowed and weeded once a week at least, filled chemicals at Cayuga water plant, did bi-weekly lift station reports and inspection, cleaned trickling filter once a week, did chores in Cayuga and Georgetown daily, did test every Thursday and Friday every week followed by reading test results every following Tuesday and Wednesday, washed lab equipment and dishes as needed after every test and sample, cleaned grit wash station once a week, cleaned rake system once a week, cut and collect all trash for pick-ups on Tuesday, cleaned septic dumping bed, decant, top off chemicals in Georgetown and Cayuga, worked on flushing hydrants Overtime hours: 9.5 hours for May 1 – 14, 2025.

- 2. **Consider Vermilion County Bi-Centennial Celebration** Todd Lee talked about the county's plans for the celebration. They will start at the Festival of Trees in November. In January/February there will be an exhibit on the Underground Railroad at the County Museum. There will be many events throughout the year. They would like to make appearances at festivals/fairs throughout the county. They will also have tours of the county.
- 3. **Consider chickens** Larry Thompson would like the council to allow chickens. His suggestion was 24 because as some get older, they will get new chickens. Alder Brooks suggested requiring signatures from neighbors in order for someone to get a permit. Alder Krabel believes it will cause more issues with pests, manure, diseases. Mr. Thompson said residents would have to have a top on their chicken run to

keep predators out. Alder Morrison mentioned the cost of keeping chickens. Buying a coop and fence, chickens, feed. It would be more for the convenience of fresh eggs, than saving money. Someone asked who's responsible when a loose dog kills someone's chickens. The number of feral cats was also mentioned. Someone suggested getting them fixed and seeing if any farmers were interested in barn cats. Someone also asked about a mobile free spay & neuter clinic. The motion was made to allow chickens; the ordinance committee would then meet to set the guidelines and write the ordinance.

- 9. **Consider Business presentation Jeremy Hall –** Jeremy and Beth Hall are restoring Bob's Pumphouse. They are planning to open an ice cream shop on the north side and make the south side a venue space. The building was built in 1912. The building needs everything roof, plumbing, electrical. They are saving money by doing a lot of the work themselves. They are hoping the Business District Committee will help them out.
- 10. **Discuss Cayuga Wells** A couple weeks ago well #2 went out a locked bearing in the motor. Ed replaced the motor. Then the communication radio went out on the same well. Both are up and running. The mayor would like to see about drilling a 3<sup>rd</sup> well as a backup. We have plenty of property there to add to it. We already have geological studies from Farnsworth. The mayor would like Ed to get some quotes. We would also have to have approval from Indiana.
