AN ORDINANCE AMENDING TITLE 6: ANIMALS

WHEREAS, the City of Georgetown, Illinois, a municipal corporation, acting through its corporate authorities, regulates the keeping and maintenance of animals within the city limits, for the purpose of preserving the peace, good order, and the comfort, convenience, and welfare of the inhabitants of the City; and

WHEREAS, the City of Georgetown, Illinois, has the authority and responsibility to make rules and regulations regarding the keeping and maintenance of animals within the geographical boundaries of the City;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Georgetown, Illinois, as follows:

Section 1. This ordinance amends Title 6, Chapter 6.05.080 of the Municipal Code of the City of Georgetown and to the extent that said chapters, or any portion thereof are inconsistent with the provisions of this ordinance, the same are hereby repealed.

Section 2. Subsection 6.05.080(b) is hereby repealed, and the following is substituted in its stead:

“Exceptions. This chapter shall not apply to areas of the city that are zoned agricultural, nor shall this chapter apply to livestock brought into the city for the purpose of being shipped out of the city, nor shall this chapter apply to the

keeping of animals by state-funded education institutions for educational purposes."

Section 3. The City Clerk is empowered to publish this Ordinance in pamphlet form.





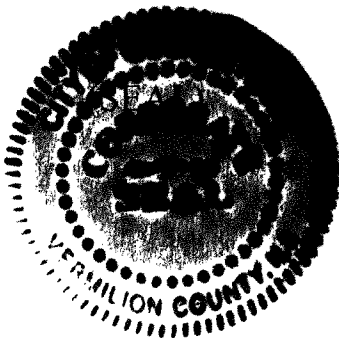
