AN ORDINANCE AMENDING TITLE 5: BUSINESS REGULATIONS

WHEREAS, the City of Georgetown, Illinois, a municipal corporation, acting through its corporate authorities, regulates the use and operation of food trucks for the purpose of preserving the safety of the residents living within the corporate jurisdiction of the City, and preserving the peace, good order, and comfort, convenience, and welfare of the inhabitants of the City; and

WHEREAS, the City of Georgetown has the authority to regulate food trucks operated within its city limits;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Georgetown, Illinois, as follows:

Section 1. City of Georgetown, Illinois Ordinance No. 2023-137 (amending Title 5) is hereby repealed in its entirety.

Section 2. The City Clerk is empowered to publish this Ordinance in pamphlet form.
