City of Georgetown, Illinois Ordinance No. 2025-173

AN ORDINANCE AMENDING TITLE 10: VEHICLES AND TRAFFIC

WHEREAS the City of Georgetown, Illinois, a municipal corporation, acting through its corporate authorities, is tasked with maintaining the safe and orderly flow of motor vehicle traffic within the City; and

WHEREAS the City of Georgetown, in order to maintain the safe and orderly flow of motor vehicle traffic, has the authority to establish rules relative to the use of public streets and alleys within the municipality.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Georgetown, Illinois, as follows:

Section 1. This ordinance amends Title 10, Chapter 16, Subsection 10.16.030, and to the extent that said chapter or any portion thereof are inconsistent with the provisions of this ordinance, the same are hereby repealed.

Section 2. Subsection 10.16.030 is hereby amended, by appending the following to the list of locations at which traffic must stop:

"At the intersection of $14^{\rm th}$ Street and Guy Street, in all four directions."

"At the intersection of $14^{\rm th}$ Street and Grace Street, in all three directions."

"At the intersection of Vermilion Street and Pearl Street, in all four directions."

"At the intersection of Stone Street and Pearl Street, in all four directions."

Section 3. The city shall erect stop signs in accordance with this amendment pursuant to Chapter 10.16.020(C).

Section 4. The City Clerk is empowered to publish this Ordinance in pamphlet form.

Section 5. This ordinance shall be effective immediately upon its passage and publication, or as soon thereafter as allowed by law.

Section 6. This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, by a majority of the members of the City Council of the City of Georgetown, Illinois, at a regular meeting of the Council on the ______ day of ________, 2025
